COMPETITION TERMS & CONDITIONS

All persons entering the Sweet Escape Competition ("the promotional Competition", alternatively "the Competition") ("the Entrants") agree that the Competition rules as set out in these terms and conditions are binding on them. Validity Date and Prizes:

- The Competition opens on 13 July 2026 and closes on 9 August 2026.
- The Prizes: 18 (Eighteen) x Pick n Pay snacks and treats basket dashes to the value of E1000 (One Thousand Emalangeni) each.
- Each Trolley Dash is valued at E1000 (One Thousand Emalangeni) and the goods may not exceed that amount. The Winner may select the items they want to keep for that value or pay the difference.
- The Winners: 18 (Eighteen) winners in total, will each win a prize.
- 2 (Two) winners will be selected per participating store at the end of the promotion.
